

California has a closed book exam for the General Contractor B license. This book's format is SOLELY designed for states like Virginia who administer an open book test. The software is also extremely disappointing unless you are someone who doesn't mind that the scoring is entirely wrong. If you can get beyond entering, for example, answer B and having the software come back saying, "Wrong. The correct answer is B." then the content within the sample tests is rudimentary but useful. Just don't complain when you get all of the right answers and the software delivers a score of 24%.

The Dewalt Contractor's guide appears to not have any proofreading done whatsoever. I bought the

Dewalt because I figured there would be some money backing this book to prevent errors like this happening. I could not get through 20 questions without finding a horrendous error. There are also parts that ask the exact same question, but give you two completely different answers. This book will drive you absolutely nuts if you are studying for an exam. Try and find a different product.

This book is filled with items that I long forgotten. I can say that it is an asset for those taking the test.

I started studying for my exam using this book. and I am extremely disapointed. There are so many mistakes in this book I spend more time marking and correcting errors in this book then I do studying. And the cd it came with has mistakes on it as well. Dewalt, love your tools...but you should probably stay out of the learning industry unless you hire someone that can proof read your books.
